CITY RESOLUTION NO. 2009-002

A RESOLUTION AUTHORIZING THE CITY TREASURER TO COLLECT THE CORRESPONDING WATER CHARGES FROM THE STALL RENTERS OF THE CITY PUBLIC MARKET OF ANTIPOLO IN ACCORDANCE WITH THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE CITY MAYOR, HON. VICTOR R. SUMULONG AND THE ANTIPOLO PUBLIC MARKET VENDORS ASSOCIATION (APMAVA) AND FOR OTHER PURPOSES.

WHEREAS, Article 99 (a) (2) (ii) of the Rules and Regulations Implementing R.A. 7160, or the Local Government Code of 1991, states that:

ART. 99. Powers, Duties and Functions of the Sangguniang Panlungsod.

(a) The Sangguniang Panlungsod , as a legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code and in the proper exercise of the corporate powers of the city as provided in Rule IX of these Rules shall:

(2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city x x x

(ii) subject to the provisions of Book II of the Code and applicable laws and upon a majority vote of all the members of the Sangguniang Panlungsod, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general welfare and specific purposes x x x ;

WHEREAS, water is essential to the maintenance of the cleanliness and sanitation of an area such as the public market which daily abounds in stinky fumes and degradable materials which are potent source of microbes and viruses; hence the city government is obliged to keep the market place a conducive and safe place, ensuring the safety of the public particularly with the food traded therein;

WHEREAS, the Manila Water Company, Inc., from which the City Government source its water supply is presently charging the city government the amount of 27.12/cu.m. in accordance to its commercial rate and since December 2007 up to the present , the City Government has not collected the amount of water bills corresponding to the consumption of the stall renters due to the inexistence of the necessary legislative measure for this purpose.

NOW THEREFORE ,


