CITY RESOLUTION NO. 2009-003

A RESOLUTION ENDORSING THE PUBLIC ORDER AND SAFETY DEPARTMENTS (POSD) DRAFT OF THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF CITY ORDINANCE NOS.2007-268, " AN ORDINANCE AUTHORIZING THE PUBLIC ORDER AND SAFETY DEPARTMENT (POSD) TO USE ORDINANCE VIOLATION RECEIPT (OVR) IN THE IMPLEMENTATION OF THE TRAFFIC CODE AND OTHER TRAFFIC-RELATED ORDINANCES OF ANTIPOLO CITY," AND 2007-269, " AN ORDINANCE DEFINING OTHER FORMS OF TRAFFIC VIOLATION COMMITTED BY OPERATORS OF PUBLIC UTILITY VEHICLES AND THEIR AGENTS AND IMPOSING PENALTIES THEREFOR".

WHEREAS, Section 6 of City Ordinance No. 2007-268, "An Ordinance Authorizing the Public Order and Safety Department (POSD) to Use Ordinance Violation Receipt (OVR) in the Implementation of the Traffic Code and Other Traffic-Related Ordinances of Antipolo City," and Section 11 of City Ordinance No. 2007-269, "An Ordinance Defining Other Forms of Traffic Violation Committed by Operators of Public Utility Vehicles and their Agents and Imposing Penalties Therefor," require the Head of Public Order and Safety Department (POSD) to "prepare the Implementing Rules and Regulations submitted to the Sangguniang Panlungsod prior to the approval of the City Mayor."

WHEREAS, on November 4, 2008, the Implementing Rules and Regulations (IRR) was submitted to the City Council by Col. (Ret.) Benjamin P. Salvador, Head of Public Order and Safety Department (POSD), in compliance with the aforesaid provision of City Ordinance Nos. 2007-268 and 2007-269, which were enacted on July 30, 2007;

WHEREAS, the said Implementing Rules and Regulations (IRR) contains stipulations that are in conformity with the provisions stated in the aforesaid City Ordinances; thus, the former possesses correspondence in the nature and grounds of the latter;

WHEREAS, the contents of the draft of the Implementing Rules and Regulations (IRR) are comprehensive and substantial; thus, these are deemed necessary for the proper and just implementation of traffic-related Ordinances in the City of Antipolo;
