CITY RESOLUTION NO. 2009-015

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND ENTER INTO, FOR AND IN BEHALF OF THE CITY, THE CONTRACT OF LEASE WITH THE TENANTS OF THE CITY MARKET OF ANTIPOLO LOCATED IN BARANGAY DELA PAZ, ANTIPOLO CITY.

WHEREAS, on December 13, 2000, the City Council of Antipolo adopted City Resolution No. 206-B-2000 entitled "A Resolution Enacting City Ordinance No. 67-2000 Otherwise Known as the 'Market Code of Antipolo City (2000)' " to improve the administration of the city's public markets;

WHEREAS, to supplement the Market Code of Antipolo City (2000), the city council enacted on December 18, 2006 City Ordinance No. 2006-254 entitled "An Ordinance

Providing for the Administration and Operation of the Antipolo City Government Mall at Barangay Dela Paz, Antipolo City and Prescribing the Fees and Changes for the lease of stalls and stores thereat and for other purposes”;

WHEREAS, a review of both ordinances will reveal that there are no provisions either in the Market Code of Antipolo City (2000) and City Ordinance No. 2006-254 that confer the necessary authority to the city mayor to enter into the Contract of Lease with the tenants of the City Market of Antipolo;

WHEREAS, both the Local Government Code of 1991 (RA 7160) and the Charter of the City of Antipolo (RA 8508) empower the city mayor to “represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to existing laws or ordinances;

WHEREAS, in order to effectively and efficiently address this pressing concern, this august body has recognized the pressing need to confer the necessary authority in favor of the city mayor.

NOW THEREFORE,


