A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND EXECUTE , FOR AND IN BEHALF OF THE CITY , THE MEMORANDUM OF AGREEMENT (MOA) WITH THE FRANCISVILLE HOMEOWNERS ASSOCIATION, INC. FOR THE CONSTRUCTION OF A SWIMMING POOL ON THE OPEN SPACE OWNED BY THE CITY GOVERNMENT OF ANTIPOLO AND LOCATED IN FRANCISVILLE SUBDIVISION, BARANGAY MAMBUGAN, ANTIPOLO CITY.
