WHEREAS, on November 17, 2008, the City Council enacted City Ordinance No. 2008-308 entitled "An Ordinance Adopting a New Structure and Staffing Pattern for the City Government of Antipolo" in order for the City to become more responsive to the demands and needs of the time particularly in the field of human resource management and development and to promote efficiency and effectivity in local governance;

WHEREAS, prior to the implementation of the aforesaid ordinance on January 02, 2009, the late City Mayor Victor R. Sumulong issued on December 02, 2008 a Memorandum declaring all positions vacant, and requesting all incumbent officials and employees who are holding regular appointments to submit their job application letters to the Human Resource Management Office not later than December 12, 2008;

NOW THEREFORE,


