CITY RESOLUTION NO. 2009-032

A RESOLUTION CONCURRING TO THE APPOINTMENT OF ATTY. EDGARDO L. SAMSON TO THE POSITION OF GOVERNMENT DEPARTMENT HEAD I (CITY LEGAL OFFICER) OF THE CITY GOVERNMENT OF ANTIPOLO.

WHEREAS, the City Mayor has forwarded to the body for concurrence the appointment of ATTY. EDGARDO L. SAMSON to the position of City Department Head I (City Legal Officer) with Salary Grade 25;

WHEREAS, said appointment, consistent with the provisions of Republic Act No. 7160 and the rules and regulations issued thereunder, is subject to the concurrence of this body. Said provisions reads:

“ART. 11. Appointment of Appointive Local Officials. –

- a.) Unless otherwise provided in this Rule, heads of offices and departments in the LGUs shall be appointed by the local chief executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations x x x.” (Article 119, Rules and Regulations Implementing the Local Government Code of 1991).

WHEREAS, Sec. 481, Art. XI of R.A. 7160 provides that:

SEC. 481. Qualifications, Terms, Powers and Duties. –

- a.) No person shall be appointed legal officer unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, and a member of the Philippine Bar. He must have practiced his profession for at least five (5) years in the case of the provincial and city legal officer, and three (3) years in the case of the municipal legal officer.

The term of the legal officer shall be co-terminus with that of his appointing authority.

WHEREAS, the body had taken stock of the qualifications of the appointee, as against the qualifications required of the position as provided in R.A. 7160, as shown in the appointee's record, particularly the following:

- 1. A citizen of the Philippines;
- 2. A resident of the City of Antipolo;
- 3. Of good moral character;
- 4. A member of the Philippine Bar
- 5. A holder of Bachelor of Science in Statistics from the University of the Philippines, Diliman, Quezon City and Bachelor of Laws from the Manuel L. Quezon University, Manila;
- 6. Has been serving the government for 21 years;
- 7. He was the Provincial Legal Officer of the Province of Rizal.

NOW THEREFORE,


