CITY RESOLUTION NO. 2009-033

A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND EXECUTE, FOR AND IN BEHALF OF THE CITY, THE MEMORANDUM OF AGREEMENT (MOA) INVOLVING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE IV, REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. RICARDO S. MARTINEZ, SR., THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA), REPRESENTED BY ITS PROVINCIAL DIRECTOR, VELMA S. SALAZAR, AND THE LOCAL GOVERNMENT UNIT OF ANTIPOLO CITY, PROVINCE OF RIZAL, REPRESENTED BY ITS MAYOR, HON. DANILO O. LEYBLE CONCERNING THE "TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED WORKERS" (TUPAD) PROJECT OF THE GOVERNMENT, AND FOR OTHER PURPOSES.

WHEREAS, Her Excellency President Gloria Macapagal-Arroyo has directed all Cabinet members to immediately implement doable pro-poor in all regions;

WHEREAS, pursuant to the said Presidential Directive, all Cabinet members have been instructed to identify and draw up one (1) livelihood project and one (1) emergency employment project which shall target to benefit the middle, lower-middle and poorest families;

WHEREAS, the government fully recognizes that the generation of employment and livelihood opportunities for targeted income groups is an economic imperative that will allow the nation to overcome the effects of the global economic crisis;

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE has been given the responsibility to implement livelihood and emergency employment projects to benefit disadvantaged workers in the CALABARZON (Region IV-A), specifically in the Municipalities of Cainta, Taytay and Antipolo City in the province of Rizal;

WHEREAS, the DOLE-RIV-A shall implement its TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED WORKERS (TUPAD) to benefit disadvantaged workers in the said LGU;

WHEREAS, TUPAD is a Project for the disadvantaged workers which aims to provide short-term wage employment as immediate source of income to a total of 17 beneficiaries and their families in Antipolo City, Rizal. It will also provide technical/vocational trainings thru TESDA-RIZAL, as well as social protection through Philhealth and SSS coverage for the beneficiaries;

WHEREAS, consistent with the vision and objectives of the State, and in local statutes, Antipolo City acknowledges the responsibility to provide a basic package of needed personal health services for the social and economic well-being of the beneficiaries of the TUPAD Project, through the implementation of the Sponsored (Indigent) Program;

WHEREAS, the TESDA was established to ensure a sustainable supply of skilled workers and technicians to all local industries within internationally and globally accepted standards;

WHEREAS, this partnership is vital to ensure the successful implementation of the said projects and achieve their desired social outcomes;

WHEREAS, in order to successfully undertake this noble and worthy pro-poor livelihood project, there is a need to confer the necessary authority in favor of the City Mayor to sign and execute the said MOA, for which reason the adoption of this resolution is earnestly enjoined.

NOW THEREFORE,

ALL PREMISES CONSIDERED, AFTER DUE DELIBERATION AND CONSIDERING THE BEST INTEREST OF PUBLIC SERVICE, ON MOTION DULY SECONDED, IT WAS RESOLVED, AS IT IS HEREBY RESOLVED, to sign and execute, for and in behalf of the City, the Memorandum of Agreement (MOA) involving the Department of Labor and Employment (DOLE) Regional Office IV, represented by its Regional Director, Atty. Ricardo S. Martinez, Sr., the Technical Education and Skills Development Authority (TESDA), represented by its Provincial Director, Velma S. Salazar, and the Local Government Unit of Antipolo City, Province of Rizal, represented by its Mayor, Hon. Danilo O. Leyble, concerning the "Tulong Panghanapbuhay sa Ating Disadvantaged Workers" (TUPAD) project of the government, and for other purposes.

RESOLVED FURTHER, that pursuant to the terms and conditions embodied in the said MOA, the City shall allocate funds as the city's counterpart for the social protection of TUPAD Project beneficiaries, for which reason it shall shoulder one hundred percent (100%) of the cost of Philhealth annual premium contribution and one hundred percent (100%) of the cost of SSS premium contribution for each beneficiary;
