SUMAYA, CONCERNING THE TRAINING OF THE NURSING STUDENTS OF TRINITY UNIVERSITY IN THE ANTIPOLO CITY HEALTH OFFICE, AND FOR OTHER PURPOSES.

NOW THEREFORE,


