**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO.2008-08 OTHERWISE KNOWN AS CY 2008 SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY CUPANG , ANTIPOLO CITY , INVOLVING AN APPROPRIATION OF ONE MILLION THREE HUNDRED TWELVE THOUSAND FIVE HUNDRED THIRTY THREE PESOS AND 50/100 (P1,312,533.50) , AS APPROVED BY THE SANGGUNIANG BARANGAY UNDER APPROPRIATION ORDINANCE NO. 2008-08 LAST NOVEMBER 28, 2008, AS OPERATIVE AS OF THE DATE OF ITS APPROVAL SUBJECT TO THE CONDITIONS IMPOSED BY THE LOCAL FINANCE COMMITTEE AS EMBODIED IN ITS REPORT DATED JANUARY 29, 2009.**

**WHEREAS,** on November 28, 2008 , the Sangguniang Barangay of Barangay Cupang, Antipolo City , enacted Appropriation Ordinance No. 2008-08 embodying the CY 2008 Supplemental Budget No. 3 of Barangay Cupang, Antipolo City, involving an appropriation of One Million Three Hundred Twelve Thousand Five Hundred Thirty Three Pesos and 36/100 (P1,312,533.50) ;

**WHEREAS,** subsequently, the said barangay supplemental budget was referred for review to the Committee on Budget, Finance and Appropriation, and after careful study and due evaluation, and taking into consideration the comments and recommendations of the Local Finance Committee as embodied in its report dated January 29, 2009, the sanggunian's Committee on Budget, Finance and Appropriation submitted a report dated February 16, 2009, adopting the report submitted by the Local Finance Committee and recommending likewise that the said Barangay supplemental budget be declared operative as of the date of its approval, subject to the conditions contained in the report of the Local Finance Committee;

**WHEREAS,** considering the favorable recommendation of both the city's Local Finance Committee and the Sanggunian's Committee on Budget, Finance and Appropriation, as reflected in their respective committee reports, this august body has resolved to adopt this resolution in order to ensure the delivery of basic services and facilities in the Barangay.

**NOW THEREFORE,**


