A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND EXECUTE , FOR AND IN BEHALF OF THE CITY, THE DEED OF SALE COVERING PROPERTY SITUATED AT SITIO KALAKAD, BARANGAY INARAWAN, ANTIPOLO CITY, OWNED BY AND REGISTERED IN THE NAME OF RODOLFO C. GALLARDO, MARRIED TO MA. TERESITA G. GALLARDO, EMBRACED IN TCT NO. R-51296, CONTAINING AN AGGREGATE AREA OF 48,076 SQUARE METERS, TO BE USED AS IMMEDIATE RELOCATION SITE OF THE AFFECTED FAMILIES ARISING FROM THE CITY AND DPWH'S CLEARING/DEMOLITION ACTIVITIES, AND FOR OTHER PURPOSES.

WHEREAS, after appraisal and inspection of the said property, it was found that the same is suitable for the purpose;

WHEREAS, in order to make the said undertaking valid and effective, there is a need for the adoption of a resolution authorizing the city mayor to sign and execute, for and in behalf of the city, the necessary deed of sale for the acquisition of the subject property;

WHEREAS, considering the magnitude of the problem of squatting and lack of public cemetery and need to adopt measures to effectively and adequately address the same, this august body has recognized the immediate necessity of approving this resolution

NOW THEREFORE,



Gallardo, embraced in TCT No. R-51296, containing an aggregate area of 48,076 square meters, to be used as immediate relocation site of the affected families arising from the City and DPWH's clearing/demolition activities, and for other purposes.
