A RESOLUTION AUTHORIZING THE HON. DANILO O. LEYBLE, CITY MAYOR, TO SIGN AND EXECUTE, FOR AND IN BEHALF OF THE CITY, THE DEED OF ABSOLUTE SALE COVERING THE PROPERTY SITUATED AT M. L. QUEZON CORNER SEN. LORENZO S. SUMULONG MEMORIAL CIRCLE, ANTIPOLO CITY, CONSISTING OF EIGHTY NINE (89) SQUARE METERS, COVERED BY TCT NO. 237967, OWNED BY AND REGISTERED IN THE NAMES OF CESAREO ANTONIO DE LEON III AND MARILYN GRACE REYES, TO BE USED IN THE CONSTRUCTION OF A TURNING BAY OVER THE 89 SQUARE METER PROPERTY TO EASE THE TRAFFIC ALONG THE AFOREMENTIONED CORNER, AND FOR OTHER PURPOSES.

Sumulong Memorial Circle, Antipolo City, consisting of eighty nine (89) square meters, covered by TCT No. 237967, owned by and registered in the names of Cesario Antonio De Leon III and Marilyn Grace Reyes, to be used in the construction of a turning bay over the 89 square meters property to ease the traffic along the aforementioned corner , and for other purposes.
